I was notified by a female who was in the area of the stage, that another female (defendant) was very intoxicated and needed to stop drinking. The female pointed out the defendant who was standing in a crowd in front of the stage. I made contact with the defendant and asked her to step out of the crowd and speak to me. The defendant was visibly intoxicated and aggressive. The defendant touched me several times and I told her each time not to touch me. The defendant became increasingly argumentative and aggressive at which point she reached forward and pushed me with her right hand on my duty belt against my will.
