# **INITIAL APPEARANCE REPORT**

(Md. Rules 4-213, 4-213.1, 4-216 and 4-216.1)

## Advice

I hereby certify that when the above named Defendant was brought before me for initial appearance, I:

ADVISED Defendant has appeared without an attorney and has a right to an attorney at the initial appearance, of the importance of having an attorney and, if indigent, the Public Defender will provide representation if the proceeding is before a judge or, a court-appointed attorney will provide representation if the proceeding is before a commissioner.

ADVISED Defendant has the right to waive the right to be represented by an attorney at the initial appearance and the waiver is only applicable to the initial appearance and not to any other hearing or proceeding.

ADVISED Defendant has an absolute right to hire a private attorney at Defendant's expense to defend against these charges. If the Defendant does not have the money to hire a private attorney, the Defendant is advised to apply right away to a District Court commissioner for representation by the Public Defender. A District Court commissioner makes the determination of whether the Defendant is financially eligible for the services of the Public Defender. After receipt of the Final Qualification, all further questions should be directed to the Public Defender's Office.

ADVISED Defendant any representation by a court-appointed attorney is provisional, limited to the initial appearance, and will terminate automatically upon conclusion of the hearing.

INFORMED Defendant of each offense charged and of the allowable penalties, including any mandatory or enhanced penalties, if any.

READ to Defendant, the Notice of Advice of Right to Counsel.

ADVISED Defendant that if Defendant appears for trial without counsel, the Court could determine that the Defendant waived counsel and the Defendant may have to proceed to trial unrepresented by counsel.

INFORMED Defendant of Affidavit for Indigent, the Defendant completed the requested affidavit and the commissioner determined with the criteria set forth in Code, Criminal Procedure Article §16-210 (b) and (c) whether the Defendant qualifies for a court-appointed attorney.

ADVISED Defendant if denied pretrial release or for any reason remains in custody after commissioner has determined conditions of release, Defendant shall be presented immediately to the District Court if the Court is then in session, or if not, at the next session of the Court, unless another attorney has entered an appearance or Defendant waives right to attorney for purpose of review before a judge, the Public Defender shall provide representation to an eligible Defendant at the review hearing.



On July 31st, 2018, Montgomery County Police Department, Special Victims Investigations Division received a report of a sexual assault.

The writer, a duly sworn Montgomery County Police Detective currently assigned to the Special Victims Investigations Division Child Abuse and Sexual Asaault Unit and Montgomery County Child Welfare Services began an investigation into the allegation of sexual assault involving a 12-year-old female victim (DOB: 11/30/2005) with special needs and the defendant, later identified as Etienne K. Kabongo (DOB 12/21/1955). The 12-year-old female victim is known to the writer and referred to as Victim A from this point forward.

The sexual assault occurred on July 31, 2018 at approximately 1230 hours on a Montgomery County Public Schools school bus that was in the area of Yates Road in Silver Spring, Montgomery County, Maryland. The sexual assault was captured via the surveillance camera inside the school bus.

On August 02, 2018, the writer reviewed the surveillance video from the school bus. Etienne K. Kabongo, a Montgomery County Public Schools school bus driver, is the bus driver that transports Victim A home after her summer program for people with special needs. In the surveillance video, after the bus attendant leaves the bus to drop off a student, Etienne K. Kabongo is observed walking past Victim A and interacting with another student in the back of the school bus. Etienne K. Kabongo then walked back to the front of the school bus where Victim A was seated by herself. Etienne K. Kabongo is observed brushing his open hand against Victim A's vagina over top of her clothing as he is walking past her. Etienne K. Kabongo then sat next to Victim on the seat and is observed placing his right hand between Victim A's legs and moved it around. Etienne K. Kabongo is observed looking out of the school bus while he right hand remained between Victim A's legs, moving around. Victim A began to scream and appears to cry while she moved backwards away from Etienne K. Kabongo . Etienne K. Kabongo partially stood up in the aisle. Etienne K. Kabongo faced Victim A and went back to the driver's seat of the school bus.

On August 2nd, 2018, Victim A was forensically interviewed by a Montgomery County social worker and disclosed that her bus driver touched her private part under her shorts. Victim A stated that it hurt and she cried. Victim A indicated that the private part she was referring to is her vagina and Victim A pointed to it. Victim A further stated that her bus driver touched the inside of her private part with his finger, and that his finger went inside of her private part.

Victim A then drew a picture of her and her bus driver and in this picture, Victim A's drawing of herself has tears coming from her eyes and she stated that she was crying.
