

NARRATIVE The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 03 day of September, 2022, at approximately 0241 a.m. p.m. at W Intl Speedway Blvd/Fentr DAYTONA BEACH within Volusia County, violated the law and did then and there:

1 In actual and physical control of a motor vehicle while driving under the influence
 2 On September 3, 2022 at approximately 0241 hours, Ofc V. Mezinord was traveling east bound on W Intl Speedway Blvd in his assigned patrol
 3 vehicle labeled "Daytona Beach Police". Ofc V. Mezinord observed a chrome 2018 Lincoln Utility (bearing FL tag#78BXXF) traveling east bound on
 4 W Intl Speedway Blvd.
 5 Veh-1 was observed by Ofc V. Mezinord weaving in and out the lane twice. Veh-1 was then observed by Ofc V. Mezinord weaving in and out the lane
 6 to the point Veh-1 almost hit a curb. Ofc V. Mezinord observed Veh-1 weave in and out of the lane once again. Ofc V. Mezinord initiated his
 7 emergency lights to conduct a traffic stop on Veh-1. Veh-1 then completed a U-Turn on Fentress blvd from W Intl Speedway Blvd and stopped on the
 8 side of the road. Ofc V. Mezinord made contact with the driver Michael Yamin (D1, identified via CT driver's license).
 9 Ofc V. Mezinord observed D1 Yamin as the sole occupant of Veh-1 in actual and physical control while Veh-1 was running. Ofc V. Mezinord advised
 10 D1 Yamin the reason of the traffic was due to failure to maintain lane. Ofc V. Mezinord asked D1 Yamin where he was coming from to which D1
 11 Yamin responded that he was coming from his father's residence down the block. Ofc V. Mezinord asked D1 Yamin for his driver's license to which



12 D1 Yamin insisted that he step out of Veh-1 to retrieve his driver's license from his pocket. D1 Yamin spoke with slurred speech. While attempting to
 13 step out of Veh-1, D1 Yamin stumbled and tripped. D1 Yamin then had difficulty maintaining his balance and began told onto Veh-1 to maintain his
 14 balance. D1 Yamin began to approach Ofc V. Mezinord. While approaching, D1 Yamin continued to stumble. SGT R. Maher responded to the scene.
 15 For the safety of D1 Yamin, officers on scene asked D1 Yamin to move from the street onto the sidewalk.
 16 D1 Yamin continued to attempt to maintain his balance while going onto the sidewalk. Per SGT R. Maher, D1 Yamin spontaneously uttered to SGT
 17 R. Maher that he knows that he is driving under the influence. Ofc V. Mezinord then advised D1 Yamin of the current situation and if D1 Yamin was
 18 willing to submit to Field Sobriety Exercises to determine if D1 Yamin is capable of operating a vehicle. D1 refused to do the Field Sobriety Exercises.
 19 Ofc V. Mezinord asked if D1 Yamin was confident in not wanting to do the Field Sobriety Exercises. D1 Yamin once again refused to the Field
 20 Sobriety Exercises.
 21 Due to the totality of the investigation, D1 Yamin was placed under custody without incident. Ofc V. Mezinord read the implied consent warning to D1
 22 Yamin in reference to the lawful test of D1 Yamin's breath to determine the alcohol content. D1 Yamin agreed to the breath test. Veh-1 was
 23 inventoried by Ofc V. Mezinord. During the inventory of Veh-1, there was only a set of golf clubs and a bottle of water. Veh-1 was towed to Daytona
 24 Wrecker located at 628 Railway St. D1 Yamin was transported to the Daytona Beach Police Department (DBPD) by Ofc C. Queliz for DUI
 25 processing. The 20 min observation period was conducted on D1 Yamin. Ofc C. Queliz administered a breath test using the Intoxylizer 8000. The first
 26 initial test resulted in 2 errors due to D1 Yamin not following the instructions of the breath test correctly. The results of the breath test are as followed:
 27 0.219g/210L and 0.227g/210L.
 28 D1 Yamin was issued two citations which were (#AGASGTE) in reference to failure to maintain lane and (#AE242UE) in reference to DUI. Incident
 29 captured on the department issued Axon.


